**ORDER:**

In the reference 1<sup>st</sup> cited, the Government have directed to constitute a District Level Anti-Ragging Committee to curb the menace of ragging in educational institutions.

- conduct of Anti-Ragging Committees periodically
- participating in anti-ragging committee of educational institutions
- keeping vigil on incident of ragging, taking immediate action on receiving distress message from victim of ragging
- Committee to study the psychological impact of ragging on students and recommend urgent and mandatory measures to be implemented in educational institutions.
- conducting sustained awareness campaigns against ragging through advertisements and publicity.

The Convenor / Member- Secretary of the Committees is requested to conduct committee meetings periodically so as to be aware of the prevailing situation in the educational institutions and to discuss about the actions to be taken to curb ragging in all educational institutions without omission. The minutes of such meetings should be sent to the Government in the Higher Education Department and to all the members of the Committee and officials concerned so as to facilitate contemplation of further course of actions.
